### TAF Warranty and Limitations of Liability

Subject to the limitations below, TAF warrants its knives to be free from defects in materials or workmanship under normal usage for ninety (90) days after original purchase date. Provided that the defective product is returned to TAF during the warranty period, postage pre-paid, together with valid, dated proof of purchase, TAF will, at its sole option, repair or replace the defective product free of charge or refund the original purchase price. This warranty extends only to the original purchaser and is not transferable. This warranty does not cover defects (such as small chips or broken tips, provided however, this type of damage can often be repaired by re-sharpening) resulting from (a) commercial use; (b) normal wear and tear; improper use, maintenance or storage; or misuse, accidents or neglect. If your knife requires re-sharpening, you must take it to a qualified knife shop that has a powered diamond-sharpening wheel.

WHERE PERMITTED, THE PROVISIONS OF THIS LIMITED WARRANTY ARE THE COMPLETE AND EXCLUSIVE STATEMENT OF WARRANTY WHICH TAF PROVIDES AND ARE IN LIEU OF ANY OTHER WRITTEN WARRANTY, WHETHER EXPRESS OR IMPLIED, WRITTEN OR ORAL, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
